




## Total DSIS Dams

# VA Dam Safety Program – Hazard Class

## Hazard Potential Classification of Dams:

4VAC50-20-40

- Dams are classified with a hazard potential depending upon the downstream losses anticipated in event of failure.
- Hazard potential is unrelated to the structural integrity of a dam. Rather it is directly related to potential adverse downstream impacts should the given dam fail.
- HIGH - dams that upon failure would cause probable loss of life or serious economic damage.
- SIGNIFICANT - dams that upon failure might cause loss of life or appreciable economic damage.
- LOW - dams that upon failure would lead to no expected loss of life and minimal economic damage.

# Regular O&M Certificate vs. General Permit


## Regular Certificate

- Certificate Term = 6 years
- Certificate Fee = \$300
- Requirements
  - EPP
  - Inundation maps
  - Inundation study
  - Spillway conveyance (100-yr/none)
  - Operation & Maintenance Plan
  - PE inspection (last 6 years)
  - Owner inspection (last year)
  - Dam condition = Satisfactory\*
  - Application w/ PE signature

## General Permit

- Permit Term = 6 years
- Permit Fee = \$300
- Requirements
  - EPP (simplified, owner-developed)
  - Inundation maps (as needed)
  - Inundation study (as needed)
  - Spillway conveyance (100-yr/50-yr/none)
  - Operation & Maintenance Plan (upon request)
  - PE inspection (upon first application)
  - Owner inspection (upon request)
  - Dam condition = Satisfactory\*
  - Registration statement w/ Owner signature

# Conditional General Permit

- Permit Term = 2 years maximum
- Permit Fee = \$200
- Requirements
  - DSIS fillable form
- Renewal
  - Written justification of extension
  - Additional time needed
  - Permit fee
  - Substantial and continual progress towards compliance
- Transition from Conditional Certificate to General Permit
  - PE inspection within last 2 years

## \*EXAMPLE LANGUAGE\*

This Conditional Operation and Maintenance Certificate is issued because the dam does not satisfy the current Regulations. The condition(s) that must be corrected to qualify for a Regular Operation and Maintenance Certificate is(are):

- Preliminary Engineering Report - Based on dam deficiencies noted in the annual inspection report by engineer dated 04/14/22, provide a preliminary engineering report (PER) using the DCR Dam Safety Inventory System (DSIS) to show what corrective actions, repairs and/or remediations that are necessary or will need to be performed at the dam to address existing emergency spillway damage, damage to the outlet conduit pipe through the dam embankment, animal burrows, and trees and woody vegetation. In addition, assess the feasibility of implementation of a low-level drain device for this existing regulated impounding structure consistent with the provisions of Section 4VAC50-20-280 of the Virginia Impounding Structure Regulations and DCR guidance document DCR-VSWCB-046. **To be completed by Wednesday, December 31, 2025.**
- Alteration Permit - Apply for an Alterations Permit using the DCR Dam Safety Inventory System (DSIS) to address noted deficiencies and subsequent corrective actions, repairs and/or remediations needed for the dam as outlined in the submitted and DCR reviewed and approved preliminary engineering report (PER). The Alterations Permit application shall be in accordance with Sections 4VAC50-20-60 and 4VAC50-20-80 of the Virginia Impounding Structure Regulations and DCR Form 199-101. **To be completed by Friday, July 31, 2026.**
- Certificate Renewal - Apply for renewal of this two-year conditional operation and maintenance certificate within ninety (90) days of expiration of the certificate, using the DCR Dam Safety Inventory System (DSIS) and DCR Forms 199-099 and 199-192 as appropriate, and in accordance with the provisions of Sections 4VAC50-20-105, 4VAC50-20-150, 4VAC50-20-350, 4VAC50-20-380, and 4VAC50-20-390 of the Virginia Impounding Structure Regulations (as applicable). **To be completed by Monday, August 31, 2026.**

This certificate is for a term of two years, effective Saturday, November 30, 2024 and expires Monday, November 30, 2026.

# Types of Low Hazard Dams

## Tier 1: “Exempt” Low Hazard Dam, Low Special – 4VAC50-20-501

- Economic damage is limited to own property (PE certification)
- No spillway conveyance requirement
- No emergency preparedness plan (EPP), only notification responsibilities
- No permit fee

## Tier 2: Low Hazard Dam – 4VAC50-20-503

- No critical infrastructure/primary highway/public utility access
- Spillway conveyance requirement = 50-YR (approval required)

## Tier 3: Low Hazard Dam – 4VAC50-20-503

- Spillway conveyance requirement = 100-YR

## Preparation Tips

- Mow
- Review last inspection report
- Bring a camera and measuring tool
- Don't open a low-level drain without a plan!

# General Permit – Registration Statement

- Certification from the owner that the impounding structure is:
- (i) classified as low hazard potential pursuant to a determination by the department or the owner's professional engineer in accordance with § 10.1-604.1 of the Code of Virginia and this chapter;
- (ii) to the best of the owner's knowledge, properly and safely constructed;
- (iii) currently has no observable deficiencies (or if deficiencies exist, such deficiencies shall be corrected in a timeframe and manner acceptable to the Department); and
- (iv) shall be maintained and operated in accordance with the provisions of the general permit.

# Hazard Creep – What To Know

**Low Hazard Dam + 1 downstream development = High Hazard Dam**

## 4VAC50-20-503.7

In order to qualify for the protections established in § 10.1-606.3 of the Code of Virginia, the owner shall file a dam break inundation zone map developed in accordance with 4VAC50-20-54 or provides the limits of the dam break inundation zone in an acceptable electronic format in accordance with 4VAC50-20-54 with the department and with the offices with plat and plan approval authority or zoning responsibilities as designated by the locality for each locality in which the dam break inundation zone resides.

## 10.1-606.3

If the Department determines that the plan of development would change the spillway design flood standards of the impounding structure, the locality shall not permit development as defined in § 15.2-2201 or redevelopment in the dam break inundation zone unless the developer or subdivider agrees to alter the plan of development so that it does not alter the spillway design flood standard required of the impounding structure or he contributes payment to the necessary upgrades to the affected impounding structure pursuant to § 15.2-2243.1.





# Summary of Owner Responsibilities

Once you have a general permit:

- Make frequent observations of the dam.
- Perform inspections of the impounding structure annually and maintain records.
- Notify the local emergency management coordinator, the Virginia Department of Emergency Management, and the department in the event of a failure or emergency condition at the impounding structure.
- Notify the department immediately of any change in circumstances that would cause the impounding structure to no longer qualify for a general permit.
- Update and resubmit the Emergency Preparedness Plan immediately upon becoming aware of necessary changes to keep the plan workable.
- Ensure that the impounding structure is properly and safely maintained and operated according to a written operation and maintenance plan.
- Do not permit growth of trees and other woody vegetation on the slopes and crest of embankments and the emergency spillway area, and within a distance of 25 feet from the toe of the embankment and abutments of the dam.

# VA Dam Safety Program – Funding Opportunities

## 2026 DSFPPAF Grant Cycle

- Application period: December 31, 2025 – March 31, 2026
- Awards announced July 2025
- 2-year work period
- Project Type I (\$1M available):
  - Private and municipal owners
  - 10% dam owner match or \$5k, whichever is higher
  - Engineering studies (Inspection, DBIZ, EAP, Alternatives analysis, Geotech investigation)
  - Unknown dams get priority
- Project Type II (\$4M available):
  - Private and municipal owners
  - 30% dam owner match
  - Final plans and Construction
  - High hazard dams get priority
  - Dams with alteration permits get priority for construction projects
