

Grand Basin Award Nomination

Clean Water Farm Award winners are eligible for Virginia's Grand Basin Awards. These awards recognize outstanding examples of farming in the Commonwealth's 10 major river basins.

Districts may submit one local Clean Water Farm Award recipient for each river basin that falls within the district's boundaries. The nominee must be approved by the district board.
